Tax bills may be paid in person at the Treasurer's Office, located in the Annex, by mail, the Treasurer's drop box, or at most county banks. Please bring or send the entire statement when paying your tax bill(s). Please enclose a self-addressed stamped envelope with your payment, for a receipt, otherwise your cancelled check is your receipt.

To pay on line, go to https://payments.municipay.com/il\_crawford, click I Agree. You can search by Parcel/Index Number, name and address. If you choose to use the autopay feature you will have an account number. Debit/Credit cards and e-checks are now accepted. A convenience fee will be charged by the payment service and late fees (if any) calculated at the checkout.

We now accept partial payments for a limited time before tax bills are generated.

To pay over the phone, call 1-844-574-1500. A convenience fee will be added.

Need a copy of your bill? Duplicate bills are available for free on-line. Simply go to crawfordil.devnetwedge.com and begin your search.

## **EXEMPTION INFORMATION**

Certain taxpayers may be eligible for tax exemptions, abatements, and other assistance programs, for more information, taxpayers should consult with the office of their township or county assessor and with the Illinois Department of Revenue.

## **EQUALIZATION INFORMATION**

The Assessed Valuation is subject to equalization by the State of Illinois and by the Local Board of Review. These multipliers, known as the "Equalization Factors," are used by the State of Illinois and local government to make assessed valuations uniform throughout the State and County. When the equalizers are determined, this produces an equalized valuation which appears on your tax bill. The equalized valuation is then subject to your local tax rate which is determined by the amount of spending by schools and local governments in your taxing district. If the use of estimated valuations or rates result in over or under extension for the overlapping taxing district in using estimated valuations or rates, the County Clerk shall make appropriate adjustments in subsequent years.

## PLEASE READ CAREFULLY

- 1) Penalty Dates: Interest added at the rate of 1 1/2% per month effective on the first day following each due date. Parts or fractions of a month shall be considered a month.
- 2) Non payment of check by your bank voids receipt.
- 3) If you are not responsible for payment of this bill, please forward to new owner or the mortgage company.
- 4) The collector is not responsible for failure to receive a tax bill, or for an omission, or for payment on wrong property.
- 5) ALL Returned checks will have a \$25.00 fee.
